**SIGN AND RETURN TO TARA HILLS STUD LTD. FOR APPROVAL**

## BOOKING AND BOARDING CONTRACT

As the owner of the mare, or the owner's agent, I hereby agree to breed the mare named on this application to your stallion subject to the following terms and conditions:

- (1) The mare owner agrees that said mare to be bred shall be healthy and in sound breeding condition. It is further agreed that the mare will be bred by artificial insemination using fresh or frozen stallion semen. The mare shall be made available for breeding through the end of the breeding season, or until pronounced in foal by an accredited veterinarian. Tara Hills Stud Ltd. reserves the right to conduct any test for breeding soundness, at the owner's expense, prior to breeding the mare, and to cancel this agreement if the findings are not consistent with the information supplied on this application or by the owner. Tara Hills Stud Ltd. may request a separate boarding contract signed for mares arriving at Tara Hills Stud Ltd. **POSITIVELY NO BLIND, CHRONICALLY LAME, VICIOUS, OR UNMANAGEABLE MARES WILL BE ACCEPTED.**
- (2) The service fee shall be due and payable immediately when the mare produces a live foal as a result of this mating. A live foal is one that can stand up alone and nurse. Payment of service fee shall be made to the order of Tara Hills Stud Ltd. The federal harmonized sales tax is applicable to all Canadian fees. **If the stud fee is not paid within 30 days of foaling, any loyalty discount may be forfeited and the full stud fee plus a 1.5% monthly service charge will apply.**
- (3) Should the mare fail to produce a live foal, the mare owner agrees to send Tara Hills Stud Ltd. a veterinarian certificate to that effect within five days of the loss of the foal in lieu of the service fee. If the mare fails to produce a live foal, a service fee paid in advance will only be refunded upon receipt of a certificate from a veterinarian stating specifically that the mare has been pronounced barren, has slipped her foal or has given birth to a dead foal, in which event the certificate must be presented to Tara Hills Stud Ltd. no later than thirty (30) days after foaling. In the event of a slipped foal, a service fee will be refunded only if the mare has been on an acceptable vaccination program during pregnancy for Equine Rhinopneumonitis (Contagious abortion). Unless such vaccinations were given at Tara Hills Stud Ltd., a veterinarian's statement giving the date of such vaccinations must accompany the claim for refund.
- (4) **THE SERVICE FEE IS DUE AND PAYABLE IMMEDIATELY IF THE MARE OR RECIPIENT MARE IS LEASED OR OFFERED FOR SALE OR IF THERE IS A CHANGE IN OWNERSHIP OF THE MARE OR RECIPIENT. NO REFUND SHALL BE DUE TO ANY PERSON, UNDER ANY CIRCUMSTANCES.**
- (5) Should the stallion die or become unfit for service before servicing the mare, or if said mare should die or become unfit to be bred, then this contract is and shall be null and void. Tara Hills Stud Ltd., in its sole discretion, shall determine the fitness of both the stallion and the mare. In addition, Tara Hills Stud Ltd., in its sole discretion, may refuse to breed any mare using the semen transport procedure.
- (6) Tara Hills Stud Ltd. shall not be liable or responsible in any manner whatsoever for disease, accident or injury to the mare or its foal, and the mare owner shall not be responsible or liable for any disease, accident or injury to the stallion.
- (7) Every mare must have a **NEGATIVE COGGINS TEST** for equine infectious anemia dated no earlier than twelve (12) months prior to the date of her arrival at the farm. A certificate to this effect must accompany the mare upon her arrival at the farm. **The mare must be vaccinated against Rhinopneumonitis, Tetanus, Strangles, and Rabies prior to arrival. Tara Hills Stud Ltd. reserves the right to vaccinate mares that arrive without vaccination documentation.**
- (8) The mare must have an identification tag on her halter upon arrival at Tara Hills Stud Ltd.
- (9) Tara Hills Stud Ltd. is authorized without liability and in its sole discretion, to engage veterinarian service, trim feet, de-worm, vaccinate, administer feed supplements, conduct veterinarian examinations or do any other work on said mare or foal deemed by Tara Hills Stud Ltd. as contributory to their general or reproductive health or appearance, with charges for such services to be billed monthly. The mare owner agrees to pay all such charges, plus board charges, within thirty days of being billed. A 1.5% monthly service charge will be added to any balance over thirty days outstanding. **Mating certificates will not be released until all financial obligations are met.**
- (10) Tara Hills Stud Ltd. will **NOT RELEASE** a mare from the farm unless the outstanding board and service fees have been settled. The boarding charges, interest charges, and other expenditures, together with the service fee herein shall be a lien upon the animal in the event of non-payment.
- (11) **In all cases where transported semen or transient ("trailer") breeding is requested, the mare owner agrees that all costs relating to these procedures (other than the actual service fees), shall be paid by either VISA, MASTERCARD, AMERICAN EXPRESS or CASH before delivery of the semen.**
- (12) **In all cases where transported semen breeding is requested, the person performing the artificial insemination assumes FULL responsibility of cross referencing the mare's freeze brand/tattoo with the label on the syringe shipped by Tara Hills Stud Ltd. and must inseminate the mare with semen of the contracted stallion.**
- (13) **If using FedEx for semen delivery, the mare owner must have a valid FedEx account number.**
- (14) **The progeny of Tara Hills stallions may be eligible to many stakes and other added money events and programs scheduled for individual racetracks in Ontario or elsewhere in Canada or the United States. Tara Hills hereby expressly waives responsibility for any changes in stakes conditions to be made by the sponsors of such stakes at any time.**
